## SAN FRANCISCO PUBLIC LIBRARY COMMISSION

## Minutes of the Regular Meeting of February 4, 2021

The San Francisco Public Library Commission held a regular meeting on February 4, 2021 virtually and telephonically pursuant to the <u>Governor's Executive Order N-29-20</u> and the <u>Sixteenth Supplement to Mayoral Proclamation Declaring the Existence of a Local Emergency dated February 25, 2020</u>. The purpose of the orders is to provide the safest environment for all persons consistent with <u>San Francisco Department of Public Health Order of the Health Officer No. C19-07e</u> and current public health recommendations, while allowing the public to observe and address the Commission.

The regular meeting of the San Francisco Library Commission was called to order at 4:30 p.m.

Commissioners Present: Huang, Lee, López, Mall, Wardell-Ghirarduzzi, Wolf and Ono.

## AGENDA ITEM NO. 2 FYs 2022 AND 2023 BUDGET

#### **Public Comment**

Peter Warfield, Executive Director, Library Users Association, <a href="libraryusers2004@yahoo.com">libraryusers2004@yahoo.com</a>, said in he had trouble with the technology joining the meeting. He commented that the Library should consider the needs of people who don't have access to computers and the internet and how the lack of access to the Library and Library services impacts them.

## Commission Discussion

Heather Green, SFPL CFO reviewed the FY 2022 and 2023 Budget and the funding priorities for the Library, commenting there were no changes to the budget from the January presentation. The FY 22 and 23 Budget required a decision from the Commission on the two options for the overall budget. Heather Green outlined how the Library's budget priorities would help with the City's economic

recovery and which option provided SFPL with greater flexibility in our current environment where there are a lot of unknowns.

Commissioner Wolf expressed her appreciation for the budget presented and giving the Commission options to be flexible and pivot when necessary. Wolf expressed support for budget option one.

Commissioner Huang shared the same perspective and support for option one of the budgets presented.

Motion: By Commissioner Wolf to adopt the budget presented with option one seconded by Commissioner Mall.

Commissioner Lee voiced support for the flexibility in budget option one. He also asked if there were economic indicators that could illustrate how the city is doing. Heather Green said there is not an established set of indicators but believed city leaders were working on that.

Commissioner Ono shared her support for budget option one.

#### AGENDA ITEM NO. 3 CITY LIBRARIANS REPORT

Michael Lambert, City Librarian, gave a presentation and updates on recent Library activities and made announcements. The following topics were covered: SFPL COVID-19 Response; DCYF Partnership – Community Hubs; Night of Ideas; and Effie Lee Morris Lecture.

Randy McClure gave an update on the Library's COVID-19 response in which he outlined the expanded services and resources available during the pandemic with a new Library service model. Randy reported about the Library's role in the last election.

Michael Lambert, City Librarian gave an update on the Library's partnership with DCYF providing Community Hubs for learning. The Library expanded the number of Hubs to include Golden Gate Valley Branch Library and plans to launch the Sunset and Ortega branches in the near future.

Michelle Jeffers, Chief of Community Programs and Partnerships shared information about the Night of Ideas Program, which was a virtual event this year because of the pandemic. 5000 people participated in the event.

Lyn Davidson, Fisher Children's Center Manager presented the 25<sup>th</sup> Annual Effie Lee Lecture series. This year the series is featuring author Jason Reynolds.

### Commission Discussion

Commissioner Mall said the Librarian's Report demonstrated the work the staff has been doing and how the Library branches have been put to work. She said the Library staff has done an incredible job under difficult circumstances and it is a testimony to their resilience and flexibility.

Commissioner Lee commended the staff and leadership team for their versatility, dedication and professionalism.

Commissioner Lopez thanked staff for the presentations and work. Commissioner Lopez asked for a future report out of types of books checked out, specifically from the bilingual collection.

Vice President Huang commented that the reports given show clearly that the Library has served as an essential backstop for the city. The grit of the staff in adapting the system is amazing work.

President Wardell-Ghirarduzzi thanked the City Librarian and his team, commenting that they have done a remarkable job and today's presentation demonstrated what makes the SFPL so special.
