Minutes of the Regular Meeting of JULY 21, 2022

The San Francisco Public Library Commission held a regular meeting on <u>JULY 21, 2022</u> virtually and at the Koret Auditorium, Main Library pursuant to Government Code Section 54953 (e) and Mayor Breed's 45th Supplement to her February 25, 2020 emergency proclamation

The regular meeting of the San Francisco Library Commission was called to order at 4:30 PM.

Commissioners Present: Wolf, Ono, Lomax Ghirarduzzi, López, and Bolander.

AGENDA ITEM NO. 1 FINDINGS TO ALLOW TELECONFERENCED MEETINGS UNDER CALIFORNIA GOVERNMENT CODE SECTION 54953(e)

Explanatory Document: Findings Resolution

Public Comment

An anonymous commenter said that the resolution is inappropriate and the Commission is not subject to the Mayor's resolution, is not subject to the Brown Act and can't decide to make findings for a remote meeting when the Mayor said a remote meeting is not necessary.

Peter Warfield, Executive Director of Library Users Association, <u>Libraryusers2004@yahoo.com</u> said there has been no discussion and no findings of fact with regards to law or with regard to circumstances and the item says you are going to have a discussion and possible action but you are not and there doesn't seem as though there is the emergency that caused the remote meetings to start.

AGENDA ITEM NO. 2 GENERAL PUBLIC COMMENT

General Public Comment

An anonymous Public Commenter said stop the hate, stop the violence, don't give money to the Friends of the Library, or accept money from the Friends of the Library. He said he attended this meeting for 38 years and the private partnership depends on a wall of lies. He asked why the Library does not take up resolutions on expenditures anymore.

Peter Warfield said recent events have made privacy much more of an important and in some cases deadly potential issue for everyone. He said the Library has ignored or changed the rules on privacy and weakened it repeatedly and there has been no privacy audit.

AGENDA ITEM NO. 3 DISCUSSION on DIGITAL STRATEGIES

City Librarian Michael Lambert introduced CIO, Michael Liang, who presented the Library Digital Strategies, which is created around the mission statement of free and equal access. Liang outlined the different digital strategies the Library uses to provide patron access including printing, laptop lending program, free internal and external wi-fi, the different mobile apps and virtual programs made available during the pandemic, and those that continue to be virtual and in-person like Tech Week.

Public Comment

Peter Warfield said we have heard a lot about internals and fantastic stuff, and the library is working toward what the public really wants but has not seen any indication that the public has been asked what it really wants and said he is skeptical of what is being pie in the sky. He said the new printing, scanning and faxing system is a failure.

President Wolf thanked Michael Liang for the presentation.

Commissioner Bolander asked if the Library has a Cyber Threat Plan.

Michael Liang responded that the Library does have a continuity and redundancy plan and backup. Liang said that with an attack the IT team could have the Library up and running within 72 hours, where it used to take up to ten days.

AGENDA ITEM NO. 4 CITY LIBRARIAN'S REPORT

Christina Mitra, James Hormel LGBTQIA Program Manager, presented the programs and partnerships offered during Pride Month like Drag Queen Story Hour and Queer Mystery Writers Panel. Mitra said SFPL participated in the Pride Parade, which for the first time in two years it was back in person and she

outlined the Inaugural Drag Laureate program and how the Library will celebrate Pride all year long.

Jaime Wong, Public Relations Officer presented an update on the SFPL Explorer Map, which was recognized as "Best in Show" for the California Library Association's Public Relations Excellence Award.

Kate Patterson reported the Library is partnering with the San Francisco Art Commission to host four Artists in Residence at the Main Library this summer. Patterson said she would be back to the Commission with additional details as each Artist conceives of their project.

City Librarian, Michael Lambert gave an overview of the ALA Annual Conference and Exhibition, held in Washington, DC from June 23-28, 2022.
